Sub: Widening of existing 2 lane road to 4/6 lane dual carriageway from Talegaon-Amravati section (including Amravati bypass) of NH-6 in km 100.000 to km 166.725 in the State of Maharashtra-Proposal allaying of 12" dia steel pipeline of Natural Gas along NH-53 from km 162.355 to km 164.755 and across at km 162.355 and km 164.550-Reg.

- Laying from km 162.355 to km 164.755.
- Crossing at km 162.355 & km 164.550.

3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
