#### Invitation of Public Comments

Sub: Pertains to permission of underground water supply pipe line crossing by HDD by 350 mm casing pipe with 180 mm dia. carrier HDPE pipe at Km. 352+001 on NH-19( Old NH-02) (Etawah - Kanpur Section) at Bamhora Humayounpur, District - Etawah in the State of Uttar Pradesh.

The office of the Executive Engineer, U.P. Jal Nigam (Grameen), Etawah has submitted the proposal for crossing of underground water supply pipeline (350 mm dia.) at Km.352+001 on NH-19 (Old NH-2) Etawah-Chakeri Section, District - Etawah in the state of Uttar Pradesh.

From the submitted proposal, it is seen that the crossing length is proposed 60.0 m at Km. 352+001. The work of pipeline execution to be carried out through HDD Method with a depth of 1.25 m from the existing ground level. Width of available ROW in LHS & RHS side is 30.0 m - 30.0 m from center of NH-19. The exiting NH is 6-lane divided carriageway.

As per the guidelines, issued by the Mort&h No. RW/NH-33044/29/2015/S&R (R) (dtd. 22.11.2016. The application shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interests).

In view of the above, comments of the public on the above application is invited to the below mentioned address, which should reach by this office within 30 days from the date of publication beyond which no comments shall be entertained.
