SUB: Projects Comprising of 9 National Highway stretches (Bundle-1) on Toll Operate Maintenance Transfer mode Bamanbore to Garamore section (from Km. 182+600 to Km. 254+537) on NH 27 in the State of Gujarat.

- Proposal seeking permission for Overhead Crossing of existing 66KV S/C Wankaner (220KV) Dhuva 'H' frame Dog Line Conversion into 66KV D/C Line on NB Tower with Panther Conductor across NH-27 in Bamanbore-Garamore section at Km 211+538 near Village-Hasanpar, Taluka-Wankaner, District-Morbi in the state of Gujarat.
