



- 1) The proposed HPCL's pipeline 14" Dia along with OFC crossing at chainage Km 142.042 of N.H-26.
- 2) The ROW width at chainage Km 142.042 is 26.32 Mtr.
- 3) The BT width with shoulder at chainage Km 142.042 is  $(10.00+2.00+2.00) = 14.00$  Mtr
- 4) The proposed HPCL's pipeline crossing on plot No.456 under Khata No.1 (Purta bibhag) of N.H-26 in Mouza- Kurlupada. It has demarcated by Amin.
- 5) Height of Embankment of proposed HPCL's pipeline at chainage Km 142.042 is 2.80 Mtr ( Av.)
- 6) This is in sufficient depth between NH carriage way & proposed HPCL's pipeline crossing.

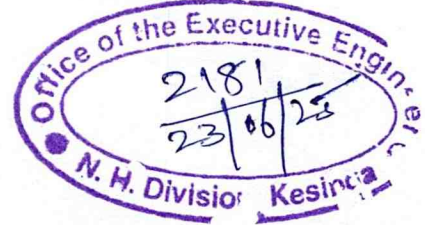

**Underground Product Pipeline will be laid as per the following details.**

1. The carrier pipe will be of 14" NB Carbon steel confirming to API-5L specifications
2. Crossing shall be undertaken by Horizontal Boring (with 20" casing pipe up to IS spec) or HDD-Method (trenchless).
3. Top of the pipeline will be laid at least 1.2 meters below the lowest Natural ground level.
4. Necessary fee in this regard, if any, shall be remitted upon receipt of advice from your side.
5. All works will be carried out as per the approved drawings.
6. During Execution of the work, all safety precaution will be ensured.
7. Location Area will be restored back to its original condition after execution.
8. All terms conditions mutually agreed with NH Department will be adhered while execution of the work.


