This has reference to letter no TSC-IV/W-116/20 dated 16.01.2024 vide which M/s DVC, Hazaribagh was submitted NH crossing proposal in respect of construction of DVC's 132 KV D/C (to be charged at 33 KV) from existing KTPS to proposed Thamb S/s of DVC. The said transmission line is proposed to cross over NH-31 at ch.11 & 12 from Barhi.

- 2. This office vide letter no-1005 dated 24.01.2024 forwarded the proposal to the Authority's Engineer for examine the proposal as per Ministry's Guideline no.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016 & other relevant circular/Guidelines issued by Ministry/NHAI. Authority's Engineer vide letter 1688 dated 07.02.2024 raised some observations. This office vide letter no 1094 dated 22.02.2024 has communicate to DVC for compliance
- 3. DVC has submitted the compliance report vide letter no 243 dated 16.04.2024 which are as below:

4	Calculation of Performance Bank Guarantee & License fee not submitted as per MORT&H Circular. Dated 22.11.2016 & subsequent amendment dated 17.04.2023	Will be submitted after final approval

4. This office has forwarded the compliance report to the Authority's Engineer for further needful action. Accordingly, Authority's Engineer vide letter no-1772 dated 29.04.2024 has reviewed the compliance report and found in order as per Ministry's Guideline.

5. This office has scrutinized the proposal and the following points are noted:

a) Proposed location of crossing between km 11 to Km 12.

b) Tower AP-19 is on the RHS of carriageway and 63.11 Mtr from road edge and AP-20 is on the LHS of carriage way and 124.49 mtr from road edge.

- c) Angle of line and road center line is shown 84 degree near km 11+260 as shown in drawing.
- d) Clearence under maximum sag conditions between lowest conductor of the proposed line and existing road is 20.20 mtr as mentioned drawing.
- e) Owing agency vide letter no-243 dated 16.04.2024 has mentioned that calculation of Performance bank Guarantee & License fee will be submitted after final approval.
- 6. In view of the above, the proposal as per MORTH circular dated 26.06.2020 and found in order.

Considering the above, as per recommendation of the Authority's Engineer, the subject proposal as submitted by DVC Hazaribagh is submitted & forwarded herewith for kind perusal and further necessary action for considering approval of temporary access permission for the subject work.
