## INVITATION OF PUBLIC COMMENTS

Sub:- NHAI-RO Kerala-4-Laning of Thrissur (Km 270.000) to Angamali (Km 316.700) and Improvement, Operation & Maintenance of Angamaly (316.700) to Edappally (Km to 342.000) on NH-47 (New NH-544) on BOT(Toll) in the State of Kerala-Laying of 90mm casing pipe (63mm PVC) from Km.332+202-Km.332+268(RHS) of NH-544- Reg.

- 1. The proposal is regarding permission sought by M/s Confident Group for laying of 90mm casing pipe (63mm PVC) from Km.332+202-Km.332+268(RHS) of NH544 in the State of Kerala.
- 2. M/s Confident Group has furnished undertaking to shift the water pipeline at their own cost at an alternate location whenever NHAI make a request for shifting of the same. Further, the applicant has undertaken for confirming with all standards as mentioned in the Ministry's Circular.
- 3. Further, M/s Confident Group has undertaken that they will not damage any other utility during the process on laying and in case, if damaged, then to pay the losses either to NHAI or to the agency concerned. Further, M/s Confident Group has undertaken to bear the expenditure incurred by NHAI for repairing any damages caused to the NH by laying, maintenance or shifting of the proposed water supply line.
- 4. As per the guidelines issued by the Ministry vide letter No.RW/NH33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by M/s Confident Group will be made available for 30 days seeking public Comments/objections and the comments shall be furnished within 30 days from the day of closure of public objections.
