It is to inform all concern that M/s CHiPS vide its office letter no. 2118 dated 25.09.2019 has submitted the proposal for laying of OFC cable from Ch.396 to Ch.362 & Ch.181 to Ch.139, Ch.123, Ch.121.7 to Ch.91, section of NH-53 (Old NH 06) on MoRT&H web portal.
