Sub: Permission for laying underground optical Fiber Cable from Ch.1.8 to Ch.16.67 & Ch.60.4 to Ch.65, section of NH-30 in the State of Chhattisgarh-Site inspection Report.

It is to inform all concern that M/s CHiPS vide its office letter no. 1265/CEO/CHiPS/BharatNet/2019 dated 24.06.2019 has submitted the proposal for laying of OFC cable from Ch.1.8 to Ch.16.67 & Ch.60.4 to Ch.65, section of NH-130 on MoRT&H web portal. In this regard, PIU Bilaspur vide letter no. 17017/1/2019/PD-BSP/OFC/CHIPS/4376 dated 13.09.2019 has submitted the site inspection report for road section of NH-130 from Km.1.800 to Km.8.00, Km.10.800 to Km.13.650 and Km.14.700 to Km.16.670 which is cumulatively 12.900 Km including the proposed crossing of NH and laying of cables on both LHS and RHS of the NH 130 under jurisdiction of PIU-Bilaspur.
