Sir,

This is in reference to Gazette Notification S.O. No.3293 (E) dated 16.09.2019 vide which Regional Officers of NHAI have been conferred with the powers to exercise sections 25, 28, 31 and 43 of the control of National Highways (Land & Traffic) Act, 2002 for the National Highways under jurisdiction of NHAI.

2. Earlier RO-Raipur has requested vide letter no.3776 dated 29.10.2019 for creation of user id in the name of NHAI Regional Office, Raipur and the same has been created by NIC Team for NHAI Regional Office, Raipur with username nhai22_2945. But due to non updation of NH-wise Chainages under jurisdiction of NHAI Regional Office, Raipur the fresh proposals are not receiving in the dash board of NHAI Regional Office, Raipur. Also, the intimation for uploading of new proposals on MoRT&H NOC Portal is not receiving in the e-mail id of NHAI Regional Office, Raipur (roraipur@nhai.org). Because the proposals are unable to view online, there might be discrepancy in proposals submitted online and proposal submitted physically to this office.


