

It is to inform all concern that M/S Jio Digital Fiber Private Limited Pune vide letter under reference (ii) has submitted a proposal for the subjected work and PD, NHAI, PIU, Aurangabad has recommended the above proposal vide letter under reference (i) for approval of the Competent Authority / Highway Administrator.

- 2. The alignment proposed by that M/S Jio Digital Fiber Private Limited Pune along NH-52 (old NH-211) from km. 174+000 to km. 177+600 for the total length 3.7 km. In the state of Maharashtra is as follows:
 - Underground Optical Fiber Cable from km174+000 to km. 177+600.
 - Alignment of the cable is along NH-52 (old NH-211).
 - Cable to be laid in trench of 1.65m depth below ground level along the highway in utility corridor.
- 3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
- 4. In view of the above, the comments / objections of affected public is hereby invited with reference to the Ministry's circular dated 22.11.2016 due to above underground line on the subjected stretch. The objections / comments may be addressed to the below mentioned address upto 17.06.2021, beyond due date, no comments/ objections will be accepted.
