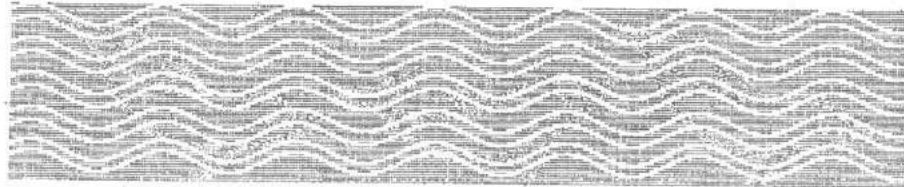
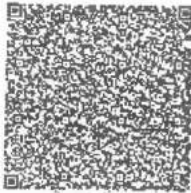

Bldg BSNL, Court Choraha, Udaipur -313001 (hereinafter referred to as BBNL) sought permission to lay 40 mm PLB pipe & underground optical fibre cable in the area (40 Kms along NH-08, from Chainage 342+075 to km 382 +040, from Barapal Telephone Exchange to Rishabhdeo) falling under the Project Director, National Highway Project Implementation Unit-Udaipur (here in after referred to as 'Principal'), who has agreed to accord permission to lay the underground cable subject to signing of an agreement and submission of performance Bank Guarantee for fulfilment of conditions of the agreement.

Now, at the request of BBNL, we CANARA BANK, a body corporate constituted under the Banking companies (Acquisition and Transfer of Undertakings) Act 1970, having its Head Office at 112 J C Road Bangalore 560002 and represented by its branch office at CANARA BANK, Parliament Street Branch, Jeevan Bharti Building, Sansad Marg, New Delhi -110001 (herein after referred to as "the Bank" which expression shall, unless it be, repugnant to the subject or context thereof include its successors and assigns) undertake to pay to the principal an amount not exceeding Rs. 40,00,000.00 (Rupees Forty Lakh only) against any loss or damages caused to or suffered by the Principal, by reason of any breach of the terms and conditions contained in the said agreement.
