Reg. Proposal for ROW permission for Overhead Crossing of 220KV Line across NE-1 between Km 23+000 and Km 24+000, Nr. Village-Mankwa, Taluka-Nadiad, District Kheda on Ahmedabad-Vadodara section of NE-1.
