

2. The said proposal has been examined in Consultation with Independent Engineer of the Project Jaipur-Kishangarh section of NH-8, M/s. LEA Associates South Asia Pvt. Ltd. - Bituminous Pavement / Paved areas of Main Carriageway / Major Bridge etc. shall not be excavated / damaged during the laying work of electric cable.
- No damage shall be done to Avenue Plantation, Electrical Cables, Project OFC, OFCs of other parties, electrical lines etc. during execution of the work. The applicant shall

be responsible solely for such damages. Applicant shall make good the damages caused to aforesaid services at its own cost.

- v) Adequate caution money may be kept as security deposit for rectification of defective works at the Risk and Cost of Agency, if the agency does not take up the works.
- vi) The applicant shall adopt adequate safety measures to avoid accidents / mis-happenings during execution of work. The applicant may be made solely responsible for such accidents / mis-happenings, if any, on account of its failure to take safety measures as may be necessary to avoid such mis-happenings.
- vii) HDD / laying of electric cable works shall be carried out only during the day time. No work may be permitted to be carried out after sunset.
- viii) As-built drawings of the completed work shall be submitted to NHAI/Concessionaire for further reference at the completion of work.
- ix) Applicant may be asked to submit the as-built drawings after completion work.

Further, IE vide their letter dated 13.02.2021 has submitted that :-

- i) The comments furnished by the Concessionaire from S. No. 1 to 9 are reasonable and agreed by IE.

4. 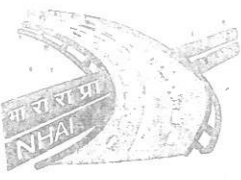




