2. The alignment proposed by M/s. Bharti Airtel Ltd, Chennai on NH-46 (Krishnagiri-Walajahpet section) in the State of Tamil Nadu as detailed under:

- 3. M/s. Bharti Airtel Limited, Chennai has proposed to lay 20mm dia OFC Cable and the top of the proposed casing pipe at a depth of 1.65 from the ground level with 40mm dia (PLB) encasing pipes along the road and 150mm RCC casing pipes across the road.
- 4. M/s. Bharti Airtel Limited, Chennai has furnished an undertaking to accept any claims raised by the Concessionaire if any and the same will be paid by them. An undertaking not to damage other utility, if damaged, then to pay the losses either to NHAI or to the concerned agency. Further, the applicant has undertaken to relocate cable lines/utilities at their own cost, notwithstanding the permission granted within such time as will be stipulated by NHAI for future development.
