Invitation of Public Comments

Sub: Proposal for grant of access permission to a new retail outlet of M/s Nayara Energy Ltd (Formerly known as M/s Essar Oil Ltd) at Km. 53 to 54 (LHS) on NH-11A Extn. of Village-Shivsinghpura, Tehsil-Lalsoth, District-Karauli in the State of Rajasthan.

M/s Nayara Energy Ltd i.e. the applicant vide letter even dated 24.07.2018 has submitted a proposal to this office on above captioned subject. This office has forwarded the proposal to PD PIU NHAI Dausa for site investigation vide this office letter dated 26.02.2019 and PD PIU NHAI Dausa vide letter no 23011/19/PIU/DAU/NOC/PP/1827, dated 16.09.2019 has submitted required report. There are exists an intersection with rural road at a distance of 53.676m, 53.716 and 53.740 which does not conform the MoRTH Norms of 300m. However the proposed retail outlet proposal is submitted in this office through service of 5.50m wide and 94m long as per the proposed drawing which will be constructed and maintained by oil company at their own cost and undertaking for the same is appended with the proposal. Therefore this proposal may be considered through the extant policy of MoRTH and accordingly Public comments (if any) are invited.

2.0 As per Ministry vide OM No. RW/ NH/33023/19/99-DO III dated 16.03.2016, the Highway Administrator will make available the relaxation proposal of Oil company for public comments, and the comments will be invited within 60 days from the day of uploading.

3.0 In view of the above the comments from public on above mentioned proposal is invited on public portal for access permission to fuel station on website of Ministry and Road Transport and Highways (www.morth.nic.in) or as per Form A (copy enclosed) on below mentioned address.
