Invitation of Public Comments

**Sub: Proposal for grant of access permission to a new retail outlet of M/s IOCL at Km. 162+300 to 162+320 (LHS) on old NH-113 (New NH-56) at Village-Banswara, Tehsil & District-Banswara in the State of Rajasthan.**

M/s IOCL i.e. the applicant vide letter dated nil has submitted a proposal to this office on above captioned subject. This office has forwarded the proposal to EE PWD NH Division Banswara for site investigation vide this office letter dated 23.08.2019 and EE PWD NH Division Banswara vide letter no 2019-20/569, dated 09.09.2019 has submitted required report. There are exists ROL at apposite side on undivided carriageway at a distance of 120 which does not conform the MoRTH Norms of 300m. However the proposed retail outlet proposal is submitted in this office through service road of 5.50m wide and 320m long as per the proposed drawing which will be constructed and maintained by oil company at their own cost and undertaking for the same is appended with the proposal. Therefore this proposal may be considered through the extant policy of MoRTH and accordingly Public comments (if any) are invited.

2.0 As per Ministry vide OM No. RW/ NH/33023/19/99-DO III dated 16.03.2016, the Highway Administrator will make available the relaxation proposal of Oil company for public comments, and the comments will be invited within 60 days from the day of uploading.

3.0 In view of the above the comments from public on above mentioned proposal is invited on public portal for access permission to fuel station on website of Ministry and Road Transport and Highways ([www.morth.nic.in](http://www.morth.nic.in)) or as per Form A (copy enclosed) on below mentioned address.
