**SUB:** Construction of Eight Lane access-controlled expressway section of Delhi-Vadodara Greenfield Alignment (NH-148N) on EPC Mode under Bharatmala Pariyojana in the state of Gujarat from Ch. 729+700 to Ch. 756+052 [Package-27]:


