Subsequently, this office vide letter under reference (ii) forwarded the proposal to Independent Engineer M/s. L.N. Malviya Infra Projects Pvt. Ltd. for its examination in light of MoRT&H's Guideline No. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016 and subsequently, IE vide letter under reference (iii) conveyed their comments with recommendation for approval.

The proposal has been examined at site by PIU Chittorgarh. Subsequently, the checklist, undertaking as per MoRT&H Guideline dated 22.11.2016 is appended with the proposal.

The license fee calculated as per the guidelines dated 22.11.2016 comes out to be Rs. 2,20,164/- (Rupees Two Lakhs Twenty Thousand One Hundred and Sixty Four Only) and the Performance Bank Guarantee towards successful completion of the work is calculated that comes out be Rs. 24,01,000/- (Rupees Twenty Four Lakhs One Thousand only). Both the amount shall be asked prior to signing of the agreement and grant of Provisional NOC.
