- Laying and erecting of 162 nos. from km 322.400 to km 324.400, km 324.400 to km 327.400 & km 326.100 to 330.100.
- 03 nos. crossing at km 324.400, km 326.100 & 328.350 (Through HDD).
- 3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
- 4. In view of the above, the comments / objections of affected public is hereby invited with reference to the Ministry's circular dated 28.01.2016 due to above transmission line on the subjected stretch.
