Invitation of Public Comments


Sub: NHAI, PIU, Coimbatore - Strengthening and Widening the existing 2 lane carriageway to 2 lane with paved shoulders from Km 0+000 to Km 85+000 of NH-544H (NH(O) Project (Thoppur -Mettur -Bhavani -Erode section) for a length of 85 Km - *Laying of water pipeline in NH544H road along the road from Km 67/4 to Km 68/4, Km 74/0 to Km 74/2 by open trench and crossing at Km 68/6 and Km 74/2 by HDD method - reg.*

1. The proposal is regarding permission for Laying of Water Pipe line in NH-544H Road (Bhavani - Erode Section) Along the road from Km Km 67/4 to Km 68/6 RHS and Km 74/0 to Km 74/2 RHS and Crossing @ Km 74/2 and Km 68/6 by Open trench & HDD method.
2. The Executive Engineer, TWAD, Maintenance Division, Erode has furnished an undertaking to accept any claims raised by the Authority, if any and the same will be paid by them and also furnished undertaking not to damage other utility, if damaged, then to pay the losses either to NHAI or to the concerned agency.
