NH83) from km 123.550 to Km. 150.400 of Dindigul - Bangalore Road (Pollachi to Coimbatore Section) to four lane with paved shoulder in the State of Tamilnadu under NHDP-IV on EPC Basis - TANGEDCO, Thamaraikulam - Submission of Proposal To Erection of 22KV Overhead Transmission Line 7/4.09mm AAAC Conductor and 45m C/C Intervals Poles Along The ROW From Km 132/974 to Km 133/559 ON RHS. And Across the Road at Km133/559 Using in 3C X 300 Sq.mm XLPE ALAR HT Cable Line Proposed Casing Pipe Dia 1.0m R.C.C BY HDD Pullback Method at Pollachi - Coimbatore section - Reg.

- 1. The proposal is regarding permission for Erection of 22KV Overhead Transmission Line 7/4.09mm AAAC Conductor and 45m C/C Intervals Poles Along The ROW From Km 132+974 to Km 133+559 on RHS and across the road at Km133+559 using in 3C X 300 Sq.mm XLPE ALAR HT Cable Line Proposed Casing Pipe Dia 1.0m R.C.C BY HDD Pullback Method at Pollachi Coimbatore section.
- 2. The Assistant Engineer, O&M, TANGEDCO/CEDC (South), Thamaraikulam has furnished an undertaking to accept any claims raised by the Authority, if any and the same will be paid by them and also furnished undertaking not to damage other utility, if damaged, then to pay the losses either to NHAI or to the concerned agency.
