Proposal for laying Natural Gas 8" Ø Carbon Steel Pipe Line from Km 50+000 Sub: to Km 59+300 (9300m) LHS & 4" Ø Carbon Steel Pipe Line from Km 54+530 to Km 55+180 (650m) RHS by HDD/Open Trench method & Carbon Steel Pipeline crossing by HDD method at Km 54+530 on NH-09 (Delhi-Amroha Section), at District-Hapur in the State of Uttar Pradesh-reg.

The Authorised Signatory, M/s Indraprastha Gas Limited has submitted the Proposal for laying Natural Gas 8" Ø Carbon Steel Pipe Line from Km 50+000 to Km 59+300 (9300m) LHS & 4" Ø Carbon Steel Pipe Line from Km 54+530 to Km 55+180 (650m) RHS by HDD/Open Trench method & Carbon Steel Pipeline crossing by HDD method at Km 54+530 on NH-09 (Delhi-Amroha Section), at District-Hapur in the State of Uttar Pradesh.

- As per the guidelines, issued by the Ministry vide OM No.RW/NH-33044/29/2015/ S&R(R) dated 22.11.2016, the application shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest). W-UP/Utility/19471 142+440 to 144+300/OH/NOC/2154 dated 23.05.2023 has also issued directions to put out the application of Public and Industrial Utility Services along and across National Highway in the public domain for 30-days for seeking public comments at PIU Level.
