Subject- Proposal for permission for laying of underground proposed 150 mm dia RCC casing duct for one phase 11 KV XLPE Electric cable with NH ROW along NH 51 (1) from km 92/630 to km 93/320 LHS (around 600 m long) and crossing across the NH-51 at km 94/170 at village Gadhada, Ta. Gadhada, Dist Botad in the State of Gujarat-Reg.

The Roads and Building Department, Government of Gujarat vide letter no. NHP-13-2025-296-M dated 16/04/2025 has recommended the subject cited proposal for permission for underground proposed 150 mm dia RCC casing duct for one phase 11 KV XLPE Electric cable with NH ROW along NH 51 (1) from km 92/630 to km 93/320 LHS (around 600 m long) and crossing across the NH-51 at km 94/170 at village- Gadhada, Tal.-Gadhada, Dist.-Botad in the State of Gujarat for approval of Highway Administration cum RO, Gandhinagar.


