The Proposal is regarding permission for laying of water pipeline in Madathukulam to Pollachi section of NH-209 (New NH-83) along the ROW from Km 101/134 to Km 101/930 on RHS by Open Trench Method by Mr.N.Thangavel & S.Velusamy has been submitted to this office by the PD, PIU, Dindigul Lr. No - NHAI/PIU/DGL/11014/10/NH-209/NOC/2023/2275 dated 17.10.2023. The proposal was returned vide Note#8 (ref. 2nd cited) as clarification/query has been raised regarding the Private utility and the clarification was sought vide MoRTH letter dated 17.12.2024(copy enclosed) where it was mentioned that the guidelines are equally applicable to 'Private utilities' as well. Accordingly, now PD has resubmitted the proposal vide Note#9 (ref.1st cited) for approval.

2) The alignment proposed by Mr.N.Thangavel & S.Velusamy for laying of water pipeline in Madathukulam to Pollachi section of NH-209 (New NH-83) along the ROW from Km 101/134 to Km 101/930 on RHS by Open trench method is as detailed under:

This has reference to your letter no. 1264 (ref (2)) as cited above, wherein we are requested to inspect the site and submit the report/comments on revised Proposal submitted by N. Thangavel Gounder & S.Velusamy for shifting of the existing underground water pipeline, along the extreme end of NH Boundary from Km 101+134 to Km 101+930 on RHS of NH-209 in Kolarpatti Village, Pollachi Taluk, Coimbatore District. as per Ministry Guidelines vide F. No. RW/NH-33044/29/2015/S&R (R) dated 22.11.2016.

In this regard, IE has checked and verified the documents submitted by the applicant Shri. N. Thangavel Gounder & S.Velusamy with reference to Ministry Guidelines vide F. No. RW/NH-33044/29/2015/S&R (R) dated 22.11.2016 and our observations are as follows:

1. The Applicant having agricultural land at Km 101+134 (RHS) and also at Km 101+930 (RHS) of NH-209. The petitioner requesting Authority for permission, to carry irrigation water supply pipe line along the ROW edge of the Highway from Km 101+134 RHS to Km 101+930 RHS of NH-83(new) for agricultural purpose.

2. The Applicant has submitted his proposal for laying underground water supply PVC pipeline of 3" diameter from Km 101+134 RHS to Km 101+930 RHS RHS (with 5" dia GI casing pipe across the cross roads) of NH-83 (new).

a. As 4-lane Project Highway is in construction stage, hence the Applicant has to coordinate with the Concessionaire to avoid any damages to the works already completed/ in progress stage.

b. The Pipe laying work involves damaging of Existing Highway by way of Drilling/excavation if any. Hence, Existing Carriageway and Shoulder portions have to be restored to the original condition as per MORT&H Specifications, with their own cost.

c. There should not be any obstruction for the safe and free movement of Traffic on either side of the Carriageway.

d. All Safety measures (like "work in progress", "Men at Work", "Go Slow" and "Diversion" signs, safety cones etc.,) shall be provided during execution of work.

Adverting to the above subject, it is submitted that the subject NOC proposal seeking access permission for laying of water supply pipeline from Km 101+134 to 101+930 on RHS in Kollarpatti Village, Pollachi Taluk, Coimbatore District for Agriculture purposes has been submitted by the applicant vide ref 4th cited.

2. In this regard, the same has been sent to Independent Engineer, to verify the proposal on ground and invited the comments vide this office letter ref 3rd cited. In turn, the Team Leader vide ref. 1st cited has furnished recommendation to the instant proposal for consideration and submitted following: -

 "The Applicant having agricultural land at Km 101+134 (RHS) and also at Km 101+930 (RHS) of NH-209. The petitioner requesting Authority for permission, to carry irrigation water supply pipe line along the ROW edge of the Highway from Km 101+134 (RHS) to Km 101+930 (RHS) of NH-83(new) for agricultural purpose.

- 2. The Applicant has submitted his proposal for laying underground water supply PVC pipeline of 3" diameter from Km 101+134 RHS to Km 101+930 RHS (with 5" diameter GI casing pipe across the cross roads) of NH-83 (new).
- 3. The Applicant has submitted the Plan and Cross sectional drawings which shows the proposed pipeline will be laid at an offset distance of 28.5m from the Project centre line. It lies within the utility corridor zone, as per CA and as per MORT&H Guidelines.
- 4. Applicant enclosed the Agreement copy, which is as per the lines specified in MORT&H Guidelines vide F.No. RW/NH-33044/29/2015/S&R (R) dated 22.11.2016.

- 11. Hence, the revised proposal of Applicant Shri. N. Thangavel Gounder & S.Velusamy may be approved/ accorded for "laying of water supply pipeline from Km 101+134 to Km 101+930 RHS of NH-209, for irrigation purpose", with the following conditions/ precautionary measures:
- a. As 4-lane Project Highway is in construction stage, hence the Applicant has to coordinate with the Concessionaire to avoid any damages to the works already completed/ in progress stage.
- b. The Pipe laying work involves damaging of Existing Highway by way of Drilling/excavation if any. Hence, Existing Carriageway and Shoulder portions have to be restored to the original condition as per MORT&H Specifications, with their own cost.
- c. There should not be any obstruction for the safe and free movement of Traffic on either side of the Carriageway.
- d. All Safety measures (like "work in progress", "Men at Work", "Go Slow" and "Diversion" signs, safety cones etc.,) shall be provided during execution of work".

3. In this context, the above proposal has been scrutinized in light of Ministry Circular No. RW/NH-33044/29/2015/S&R (R) dated 22.11.2016 and the following points are brought out:

- i. A plan showing the above-mentioned NH stretch with the proposed Pipeline location, cross section of Pipeline Trench has been appended in the proposal.
- ii. The water supply pipeline is proposed to be laid 1.2m below from Ground level/Sub-grade which is satisfying the norms.
- iii. The applicant has submitted an agreement in the prescribed format to be executed in case the approval is accorded.
- iv. The applicant has submitted the necessary undertakings in the prescribed format as mentioned in the Ministry Circular No. RW/NH-33044/29/2015/S&R (R) dated 22.11.2016.

4. The license fee has been calculated for PVC pipeline of 3" diameter from Km 101+134 (RHS) and also at Km 101+930 (RHS) proposed in line with the MoRTH policy guidelines dt. 22.11.2016 & 17.04.2023 as detailed below:

6. Further, it is to certify that the proposal is confirming all the standard conditions issued vide Ministry Circular, the installation of pipeline within ROW will not adversely affect the design, stability & traffic safety of the Highway nor the

future improvement such as widening of the carriageway, easing of curves etc., and it is certified that the sufficient ROW is available at site for accommodating proposed 4 lanning.

7. In view of above, the in-principal approval/ provisional NOC of the Competent Authority to lay the Underground Water Pipeline using PVC carrier pipe Dia 76.2 mm (3") along from Km 101+134 to Km 101+930 on RHS on NH-209 (new NH-83), Coimbatore District for Agricultural purpose may be accorded to the applicant Shri. N. Thangavel Gounder & Shri S. Velusamy.
