Sir,

In inviting a kind reference to the above captioned letter on the cited subject, it is to furnish herewith necessary point wise compliances in respect to the observations relating to aforesaid proposal for your kind favourable consideration being smooth implementation of Govt. scheme like basic facilities of drinking water to the public under Kesinga NAC.

2 (a): That, in the proposed chainage where to be laid water supply pipe lines i.e. (i) from Km.143/900 (Balangir chowk) to Km.146/950 (FCI) on LHS comprising a length of 3.050 km of NH-26 is coming to the drain corridor along with concrete paved shoulder exist within the town ship built up area and (ii) from Km.146/950 (FCI) to Km.147/800 (Boringpadar) & (iii) from Km.147/800 (Boringpadar) to Km.148/300 are stands 2L+PS configuration without drain corridor. Considering to the above, proposed pipelines to be laid in extreme end towards drain within the stretch stated in sl-(i) wherein C.C paved shoulder will be cut for laying pipeline as persist constrain built-up area and the stretches stated in sl-(ii) & (iii) therein to be laid pipelines extreme end of ROW i.e. put toe line of embankment. On occurrence of damages while laying of pipelines, required restoration shall be carried out by the applicant, for which the S.E, PHD Bhawanipatna has already been furnished undertaking on dtd.25.11.2024.

2 (b): That, keeping in view the upcoming widening work i.e. 4L+PS under proposed Kesinga-Bhawanipatna-Junagarh of NH-26, now proposed to be laid pipelines within the Kesinga NAC built up area will be needed for shift to other location. During further widening in that stretches, land acquisition should be approached considering to the now available ROW. Hence, such pipelines ought to be shifted to extreme end of upcoming ROW by the water supply owing department at his own cost & risk. In this context, the S.E, PHD Bhawanipatna has already submitted requisite affidavit form refer to checklist condition along with their application and now further furnish declaration regarding shifting of pipelines vide his letter No.758 dtd.06.03.2025, which copy is enclosed herewith for your kind ready reference.

In view of the above facts taking into consideration being essential service like basic water supply facilities through the concern Department, it is hereby recommended to allowing them to go-ahead with their pipelining assignment to productive implementation of Govt. scheme as per your good office approval in line of Ministry's relevant guidelines vide F.No.RW/NH-33044/29/2015/S&R(R) dtd.22.11.2016 and other statutory terms & conditions, which would be strictly adhered during execution at site. Therefore, it is requested to kindly consider the proposal and issue suitable permission thereto.

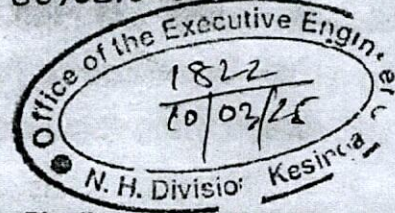


