Project Director, NHAI, PIU-Daltonganj vide letter no. 612 dated 19.07.2025 has submitted the proposal for 'Permission of NOC for laying of water pipeline along/across the NH in NH-98 at different locations' for further necessary action.

As per Ministry circular issued vide OM no. RW/NH/33044/29/2015/S&R(R) dated 22.11.2016, the Highway Administration shall make available the proposal for granting license for use of National Highway land for laying utility service for public comments for 30 days on ground of public interest.

This is in reference to the letter cited above vide which proposal for laying of pipeline has been submitted.

2. IE vide letter dated 16.06.2025 has recommended the proposal for further processing. The following has been proposed -

- Laying of Pipeline of Dia 400mm from Ch. 51.900 to Ch. 57.000.
- Crossing in between Chainage 50.400 to 50.500 (1 nos.) and between Ch. 52.300 and 52.500 (1 Nos.) by HDD method

4. The proposal has been examined and it is found to be as per the MoRTH guideline dated 22.11.2016 and 17.04.2023.
