Whereas Authority is responsible, inter -Alai for development and maintenance of land along NH-52 (Old NH-13) (Solapur - Vijayapur road Section) in the state of Karnataka, at chainage KM 73+350 to KM 73+950 of NH No 52 RoW near Horti village, Indi Taluk, Bijapur dist.

Whereas the Licensee proposes to lay MS pipeline in the utility services in subsequent paras.

Whereas the licensee has applied to authority for permission to lay utility services in the following chainages of NH-52 from KM 73+350 to KM 73+950 near Horti village, Indi Taluk, Bijapur dist.

And whereas the Authority has agreed to grant such permission for way leave on the NH RoW as per the terms and conditions hereinafter mentioned.

Now this agreement witnesses that in consideration of the conditions hereinafter contained and on the part of the Licensee to be observed and performed. The Authority hereby grants to the Licensee permission to lay utility services as per the drawings attached hereto subject to conditions, namely:-

- 1. ROW permission are only enabling in nature. The purpose of extending the way have facility on the National Highway ROW is not for enhancing the scope of activity of a utility service provider, either by content or by intent. Further enforceability of the permission so granted shall be restricted only to the extent of provisions/scope of activities defined in the license agreement & for the purpose for which it is granted.
- 2. No license shall claim exclusive right on the ROW and any subsequent user will be permitted to use of the ROW, either above or below, or by the side of the utilities laid by the first user, subject to technical requirements being fulfilled. Decision of the authority in relation to fulfillment of technical requirements shall be final and binding on all concerned parties. In case any disruption/damage is caused to any existing user by the subsequent user, the authority shall not be held accountable or liable in any manner.
- 3. The licensee shall responsible for undertaking all activities including, but not limited to the site identification, survey, design, engineering arranging finance, project management, obtaining regulatory approvals & necessary clearances, supply of equipment, material, construction, erection, testing and commissioning, maintenance and operation and all other activities essential or required for efficient functioning on their own utility/industrial infrastructure facilities.

- 7. The utility services shall be laid at the edge of the RoW. In case of restricted width of RoW. Which may be adequate only to accommodate the carriageway, central verge, shoulders, slope of embankment, drains, other road side furniture etc, the utility services shall be laid beyond the toe line of the embankments and clear of the drains.
- 8. The licensee shall make his own arrangements for crossing of cross drainage structure, rivers etc. Below the bed in case, this is not feasible. The utility services may be carried outside the railings/parapets and the bridge superstructure. The fixing and supporting arrangement with all details shall be required to be approved in advance from the concerned Highway Administration. Additional cost on account of fixing and supporting agreement as assessed by the authority shall be payable by the licensee.
- 9. In exceptional cases, where ROW is restricted the utility services can be allowed beneath the carriageway of service road, if applicable, subject to the condition that the utility services be laid in concrete ducts, which will be designed to carry traffic on top. The width of the duct shall not be less than one lane. In such cases it also needs to ensure that maintenance of the utility services shall not interfere with the shape and smooth flow traffic. The cost of operation and maintenance will have to be borne by the licensee
- 10. It is to be ensuring that at no time there is interference with the drainage of the road land and maintenance of National highways. Towards this, the top of utility services shall be at least 0.6 meter below the ground level. However, any structure above ground shall be aesthetically provided for /landscaped with required safety measures as directed by the concerned authority.
- 11. The utility services shall be permitted to cross the National Highway either through structure or conduits specially built for the purpose. The casing/conduits pipe should, as minimum, extend from drain to drain in cuts and toe of the slope to toe of the slope

- 12. Existing drainage structures shall not be allowed to carry the line across.
- 13. The top of casing/Conduit pipe containing the utility services to cross the road shall be at least 1.2m below the top of the sub grade or the existing ground level whichever is lower, subject to being at least 0.3m below the drainage inverts. A typical sketch showing the clearance is given in attachment.
- 14. The utility services shall cross the National Highway preferable on a line normal to it or as nearly so as perpendicular.
- 15. The casing/conduit pipe for crossing the road may be installed under the road embankment either by boring /digging the trench. Road crossing is not applicable.
- 16. In case of trenching, the sides of the trench should be as nearly vertical as possible. The trench width should be at least 1.5m but not more than 2.0m. wider than the outer diameter of the pipe. Filling of the trench shall confirm to the specifications contained herein below or as supplied by the Highway Authority.
  - a) Bedding shall be to a depth not less than 30cm. Is shall consist of granular material, free lumps, clods and graded to yield a firm surface without sudden change in the bearing value. Unsuitable soil and rock edges should be excavated and replaced by selected material.
  - b) The back fill shall be completed in two stages (i) side fill to the level of the top of the pipe (ii) overfilled to the bottom of the road crust.
  - c) The side filled consist of granular material in 15cm. Layers each consolidated by mechanical temping and controlled addition of moisture to 95% of the proctor's density. Overfill shall be compacted to the same density as the material that had been removed. Consolidation by saturation on ponding will not be permitted.

The licensee shall shift the utility services within 90 days (or as specified by the respective authority) from the date of the issue of the notice by the concerned authority to shift/ relocate the utility services, in case it is so required for the purpose of improvement/widening of the road/route/highway or construction of flyover/bridge and restore the road/land to its original condition at his own cost and risk.
- 22. The licensee shall responsible to ascertain from the respective agency in coordination with authority, regarding the location of the other utilities/underground installation /facilities etc. The licensee shall ensure the safety and security of already existing underground installation/utilities/facilities etc, before commencement of the excavation /using the existing ducts. The licensee shall procure insurance from the reputed insurance company against damages to already existing underground installation/utilities/facilities etc.
- 23. The licensee shall be solely responsible/ liable for full compensation/indemnification of concerned agency /aggrieved authority for any direct, indirect or consequential damages caused to the claims or replacements sought for, at the cost and risk of the licensee. The concerned agency in coordination with authority shall also have a right make good such damages/recover the claims by forfeiture of bank guarantee.
- 24. If the licensee fails to comply with any condition to the satisfaction of the authority, the same shall be executed by the authority at the cost and rocs of the licensee.
- 25. Grant of the licensee is subject to the licensee satisfying (a) minimum disruption of traffic and (b) no damage to the highways. As far as possible, the licensee should avoid cutting of the road for crossing highway, and other roads and try to carry out the work by trenchless technology. The licensee shall inform/ give a notice to the concerned agency designated by the authority at least 15 days in advance with route details prior to digging trenches, for fresh or maintenance/repair works. A separate performance bank guarantee for maintenance/repair works shall have to be furnished by the licensee.
- 27. Each day the extent of digging the trenches should be strictly regulated so that a utility service is laid and trenches filled up before the close of the work that day. Filling should be completed to the satisfaction of the concerned agency designated by the authority.
- 28. The licensee shall indemnify the concerned agency in co-ordination with authority, against all damages and claims, if any due to the digging of trenches for laying cables/ducts.
- 29. The permission for laying utility services is granted maximum for 5 years at a time, which can thereafter be consider for renewal. On payment of additional fee at the time of renewal. The permission shall automatically be renewed, unless defaults exist. In case of renewal, rate prevailing at the time of renewal shall be changed. Delay in deposition of fee shall attract interest @ 15% per annum compounded annually.
- 30. The permission shall be valid only for the period it is issued and fee deposited. However, the authority also has a right to terminate the permission or to extend the period of agreement.
- 31. That the licensee shall not undertake any work of shifting, repairs or alteration to the utility services without prior written permission of the concerned agency in coordination with the Authority.
- 32. The permission granted shall not in any way be deemed to covey to the licensee any ownership right or any interest in route/road/highway land property, other than what is herein expressly granted. No use of NH ROW will be permitted for any purpose other than that specified in the Agreement.
- 33. During the substance of this Agreement the utility services located in highway land/ property shall be deemed to have been constructed and continued only by the consent and permission of the authority so that the right of the licensee to the use their off shall not become absolute and indefeasible by lapse of time.

#### Methodology of laying MS pipeline along NH-52

#### **Trenching Method:**

Laying of MS pipeline along NH-52 will be done by conventional method i.e Manual and Machine trenching method. The dimension of the trench will be 2.20 mtr in depth and 1.5 mtr in width. Pipeline laying work will be carried out in phased manner in such a way that after the laying of pipeline, the trench will be reinstated to its original surface.

#### **Trench Filling Method:**

As a masure of abundant precaution against future settlement and other allied problems, only selected granular material will be used in filling reinstatement of trenches. The entire depth of cutting will be filled with excavated material, compacted in layers not exceeding 75 mm when compacted by ordinary power roller/ plate compactor. Special Compaction equipment like plate compactor, frog hammer will be utilised besides ordinary power roller.


#### Safety Measures for Laying Pipeline along the NH:


# TYPICAL CROSS SECTION OF TRENCH LAYING OF 910 MM DIA MS PIPELINE
