The Roads and Building Department, Government of Gujarat vide letter no. NHP-13-2023-425-M dated 26/07/2023 has recommended the subject cited proposal of M/s Gujarat Gas Limited for laying 4" dia steel/125mm dia PE pipeline parallel to NH-927D (Doraji-jmkondona-Kalavad-jamnagar road) from Ch.60/760 to 58/434 in both side of NH (RHS & LHS) and crossing at km 58/434 to supply the natural gas to Kalavad village, Taluka-kalavad, Distict-Jamanagr in the state of Gujarat for approval of Highway Administration cum RO, Gandhinagar.


