 - Proposal seeking ROW permission for Overhead Crossing of 66KV S/C on D/C Sevaliya (Thermal tower)-Fagwel Transmission Line across Ahmedabad-Indore NH-47 between Km 66+000 and Km 67+000 in the state of Gujarat.
