

It is to inform all concern that M/s Jio Digital Fiber Pvt. Ltd. vide letter under reference (ii) has submitted a proposal for the subjected work and PD, NHAI, PIU, Amravati has recommended the above proposal vide letter under reference (i) for approval of the Competent Authority / Highway Administrator.

- 2. The alignment proposed by that M/s Jio Digital Fiber Pvt. Ltd from Nandura Kh. to Bahapura from km. 316.000 to km. 340.000 (LHS) along the NH-6 in the State of Maharashtra is as follows:
 - Underground Optical Fiber Cable from km. 316.000 to km. 340.000 (LHS).
 - Alignment of the cable from Nandura Kh. to Bahapura from km. 316.000 to km. 340.000 (LHS) is along the NH-6, to be laid in utility corridor.
 - 3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
 - 4. In view of the above, the comments / objections of affected public is hereby invited with reference to the Ministry's circular dated 22.11.2016 due to above underground line on the subjected stretch.
