The proposal is regarding for laying of underground Gas pipeline along the road from Km 286/870 to Km 338/030 (51160 m) on LHS by Open Trench Method and HDD Method in the State of Andhra Pradesh and from Km 0/000 to Km 03/770 (3770 m) on LHS by Open Trench Method and HDD Method in the State of Tamil Nadu in Tirupathi - Tiruttani -- Chennai section of NH-205 submitted to this office by M/s. AG&P City Gas Private Limited., Chennai letter No. dated Nil received by this office on 24.01.2022.

2. The details of proposal are as under:

a. The above proposal pertains to the laying of underground Gas pipeline along the road from Km 286/870 to Km 338/030 (51160 m) on LHS by Open Trench Method and HDD Method in the State of Andhra Pradesh and from Km 0/000 to Km 03/770 (3770 m) on LHS by Open Trench Method and HDD Method in cross roads and cross drainage structure locations.

b. The available width of ROW from 30.0 m from existing centre line.

AG&P City Gas Private Limited., Chennai has furnished an undertaking to accept any claims raised by the Concessionaire if any and the same will be paid by them and furnished undertaking not to damage other utility, if damaged, then to pay the losses either to NHAI or to the concerned agency.
