Executive Engineer NH Division, Sitamarhi vide letters cited as ref (i) & (iv) above has requested to grant relaxation as per Ministry's circular no. RW/NH-33023/19/99-DO III dated 16.03.2016.

2. The provisional access permission for retail outlet mentioned under subject above was granted vide this office letter no. RW/PAT/NH/104/156.543/PP/2016(P)-1005 dated 18.09.2017 with the condition that, "The licensee shall, within three months from date of receipt of the permission, but without interfering in any way with the highway traffic, complete the construction of the approach road (including deceleration/acceleration lanes) and shall make provision for drainage, signs and marking at his own cost and to the full satisfaction of the Executive Engineer, NH-Division, Sitamarhi, RCD (Bihar) according to approved drawing and specification."

3. As per the completion certificate submitted by Executive Engineer, NH-Division, Sitamarhi, RCD (Bihar), The construction of the approach road (including deceleration/acceleration lanes) has been completed on 18.05.2020 as per approved drawing and conditions mentioned in provisional NOC.



Executive Engineer, NH-Division, Sitamarhi, RCD (Bihar) vide letter no.414(WE) dated 18.06.2020 has informed that the construction of the approach road was delayed due to ongoing construction work on NH-104. Further, Oil company vide letter no. MDO/RO/Bela Belhi/01 dated 16.06.2020 has requested to grant relaxation as per Ministry's circular no. RW/NH-33023/19/99-DO III dated 16.03.2016.

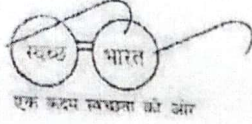


