  - Laying of underground Optical Fiber Cable from Shewali village Ch. km
     571.800 to Sakri city km
     575.200 Total length 3.4 kms.
  - Cable to be laid along highway by trenching in utility corridor.
  - Cable to be crossed by HDD method at kn. 573.800.
