The alignment proposed by M/s Maharashtra Information Technology Corporation Ltd. for installation of Overhead Optical Fibre Cable on existing MSEDCL pole and / or erecting new poles along on NH-361 section of Loha - Waranga & Waranga - Mahagaon Road Ch. km 252.400 to km 260.120 the total length of 7.72 kms. The following activity is involved:

- Installation of OFC cable on existing MSEDCL Pole or by erecting new poles at edge of ROW along NH-361 section of Loha - Waranga & Waranga - Mahagaon from km 252.400 to km 260.120.
