i)	Non Fulfillment of Criteria distance from	As the permission is sought for construction of commercial shop & warehouse where the heavy movement of trucks & trailers would be there so connecting the two service road &
		taking access from slip road will result in conflict of traffic & that may lead to traffic issues. Hence sought access in front of internal road so that the movement of trucks would be restricted & there would be no hindrance to traffic on NH.
