**Sub: Proposal for grant of NOC for access permission to NH and approach license agreement for a new retail outlet of M/s IOCL on NH-25 from CH.182.833 to CH. 182.868 (RHS), village- Shilp Gram Pal, Tehsil- Jodhpur, District-Jodhpur in the state of Rajasthan.**

M/s IOCL i.e. the applicant vide letter no. IOCL/JDH/NHAI/07, dated nil has submitted a proposal to this office on above captioned subject. This office has forwarded the proposal to SE PWD NH Circle Jodhpur for site investigation vide this office letter dated 07.01.2020 and SE PWD NH Circle Jodhpur vide letter no. SE/NH/Ju/2019-20/353, dated 21.01.2020 has submitted required report. The proposed retail outlet proposal on proposed service road as per the proposed drawing, if not construct proposed service road by NH Circle Jodhpur, the 5.5m wide and 348m length of service road will be constructed and maintained by oil company at their own cost. In this regard a undertaking for the same is appended with the proposal. Therefore this proposal may be considered through the extant policy of MoRTH and accordingly Public comments (if any) are invited.

2.0 As per Ministry vide OM No. RW/ NH/33023/19/99-DO III dated 16.03.2016, the Highway Administrator will make available the relaxation proposal of Oil company for public comments, and the comments will be invited within 60 days from the day of uploading.
