**Subject:** Access Permission for New Retail Outlet abutting (LHS) of NH-66(OldNH-17) (Panjim/Panvel-Mangalore section) at Km.524/564 (DE.CH 524.526) in Property bearing Sy.No.91/8, of Bambolim Village, Tiswad Taluka, North Goa District, Goa State.

EE (NH) Div-XII, Panaji Goa letter No.F.12/2017-18/PWD/WDVII(NH)/ASW/1924, dated-22.01.2018 has submitted access permission for new retail outlet abutting (LHS) of NH-66(OldNH-17) (Panjim/Panvel-Mangalore section) at Km.524/564 (DE.CH 524.526) in Property bearing Sy.No.91/8, of Bambolim Village, Tiswad Taluka, North Goa District, Goa State.

2. As per guideline issued by Ministry vide letter no. RW/NH-33023/19/99-DO-III, dated 16.03.2016 according to which for relaxation cases the Highway Administrator will make available in Ministry website the complete application for public comments and comments will be invited within 60 days from the day of uploading as per the format enclosed as Form-A. As per proposal due to following the relaxation is sought by applicant.

i)	Ministry checklist clause 9.b i.e. depth of plot does not fulfills minimum criteria.	As the minimum frontage i.e 35mts frontage is available and there is a shortfall of 175sqmts from the minimum plot area required, So as the shortfall is nearly 10% of the minimum area required the relaxation is sought and also the plot location is existing in the Goa near Town location, the availability of the area of 35x45 is very difficult to acquire. Kindly consider the same under relaxation.
