Invitation of public comments

Sub: Proposal for grant of NOC for access permission for Retail Outlet of M/s IOCL at Chainage 191.463 to 191.518 (LHS) on NH-11 at khasra No. 150, at Village –Laximipura, Tehsil-Bassi, District –Jaiipur in state of Rajasthan.

M/s IOCL ie. the applicant vides letter No. laxipura/Morth-05 dated 05.09.2019 has submitted a proposal to this office on above mentioned subject. The applicant has sought relaxation from Ministry Guidelines issued vide letter No. RW/ NH-33023/19/99-DO.III dated 24.07.2013 as there are two intersection of NH with a rural roads at a distance of 68m and 234m from the proposed retail outlet (as per checklist on same side of ROL as against minimum stipulated distance of 300m as per Ministry's Guidelines) The applicant has proposed to make a 7.0m wide service road along with 275mm raised Turfed separator island from point A to D in the Drawing. This serviced road cover both the intersections and main carriageway traffic separated by 275mm Raised Turfed Separator island.

- 2. PD -Dausa has made correction in the general drawing proposing a separator of 0.6m Height from Point A to D in the drawing. This requirement is not in accordance with Ministry standard drawing appended with Ministry's Guidelines issued vide letter No. RW/NH-33023/19/99-DO-III dated 24th July 2013 and 25.08.2014 and Highway Administration also not agree with this Correction, hence not accepted. island with 275mm raised Turfed will act as separator and will ensure safe movement of road user. PD, PIU, NHAI-Dausa vide his letter no. 2405 dated 06.11.2019 forwarding Joint inspection report along with signed copy of proposal. The proposal found in accordance with Ministry's guidelines dated 24.07.2013 & 25.08.2014.
- 3.0 As per Ministry vide OM No. RW/ NH/33023/19/99-DO III dated 16.03.2016, the Highway Administrator will make available the relaxation proposal of Oil company for public comments, and the comments will be invited within 60 days from the day of uploading.
- 4.0 In view of the above the comments from public on above mentioned proposal is invited on public portal for access permission to fuel station on website of Ministry and Road Transport and Highways (www.morth.nic.in)
- 5.0 This is issued with the approval of Highway Administration-cum Regional Officer, MoRTH, Jaipur.
