### Invitation of Public Comments

**SUB:** Short Term Improvements & Routine maintenance of Surat - Vapi Section from Km. 263.000 to Km. 381.000 on NH-48 in the state of Gujarat

- Proposal seeking ROW Permission for laying & crossing of 500mm/400mm/250mm Diameter Underground Drinking Water Pipeline along (i) from Km 318+600 to Km 319+050 on LHS, (ii) from Km 318+600 to Km 319+000 on RHS and (iii) Crossing at Km 318+600 and (iv) at Km 318+625 on NH-48 in Chimla/ Balvada Village, Taluka-Chikhli, District-Navsari for Drinking Water Supply Pipeline under Chikhli Amandhara RWSS, in the state of Gujarat.


