The Project Director, PIU - Amaravati submitted a proposal of M/s. IOCL for laying of 4" dia. carbon steel pipeline for Public Utility - "City Gas Distribution" along the NH-16 from Km.430+630 to Km.431+030 (LHS) and from Km.431+030 to Km.435+233 (RHS) with crossing at Km.431+030 for a total length of 4703m (4603 m along and 100m crossing) and 125mm MDPE pipe along with 40mm HDPE duct for OFC on Chilakaluripet - Vijayawada section of NH-16 in the State of Andhra Pradesh.

As per MORTH guidelines vide letter No. RW/NH-33044/29/2015/S&R(R) dated 22nd November 2016, the Highway Administration will put out the application in the Ministry's website for 30 days seeking claims and objections (on grounds of public inconvenience, safety and general public interest).

It is to inform that M/s IOCL vide reference 1st & 6th cited, requested permission for laying of steel pipelines for Public Utility - "City Gas Distribution" along the NH-16 from Km.430+630 to Km.431+030 LHS and from Km.431+030 to Km.435+233 RHS with crossing at Km.431+030 for a total length of 4703m (4603 m along and 100m crossing) on Chilakaluripet - Vijayawada section of NH-16 duly citing the MOU signed between M/s IOCL and NHAI on 07.06.2022 for laying of gas/petroleum pipeline(s) along and across National Highways Corridors and vice versa.

- 2. The above proposal was forwarded to IE, M/s MSV Intl. Inc. in association with M/s Sri Infotech, with a request to examine the proposal, with reference to site and MOU signed between M/s IOCL and NHAI on 07.06.2022 and furnish necessary commends/recommendations for taking further action.
- 3. Accordingly, IE, MSV Intl. Inc. In association with M/s Sri Infotech vide reference 3rd cited submitted that IE has reviewed the proposal with reference to site and MOU signed between M/s IOCL and NHAI on 07.06.2022 and the observations of IE are as follows:
 - I. The applicant has submitted Checklist for laying a 4" dia Carbon steel pipeline (API 5L x 52 grade, 0.25" wall thickness) & 125mm MDPE pipeline along with 40mm HDPE duct for OFC cable along the National Highway from Km.430+630 to

H.Q.: G-5 & 6, Sector - 10, Dwaraka, New Delhi - 110 075,

Km.431+030 LHS and from Km.431+030 to Km.435+233 RHS with crossing at Km.431+030.

The information furnished in the checklist is satisfying all the conditions of the Ministry guidelines vide F.No. RW-NH-33044/29/2015/S&R(R) dated 22.11.2016

- II. The applicant has submitted following undertakings:
- 1. To take responsibility for the safety of all other underground facilities, such as electric lines, pipe of water supply and gas sewage lines etc., during trenching.
- 2. To inform the concerned officer of NHAI appointed at least 15 days in advance before starting of work.
- 3. To obtain prior permission in writing to the concerned officer of NHAI to undertake any work of shifting, repairs or alteration to the laid pipeline by Indian Oil Corporation Limited, Pipeline Division, City Gas Distribution, Guntur.
- 4. NHAI shall not be responsible for any damage caused to the underground R-LNG pipeline or by any activity of NHAI of the permitted highway. The parties are agreed that the Indian Oil Corporation Limited, Pipelines Division, City Gas Distribution, Guntur is laying an underground LNG pipeline across the permitted highway at its own cost.
- 5. To make good excavated trench for laying underground R-LNG pipeline by proper filling and compaction, so as to restore the land in the same condition as it was before digging trench and shall clear the debris/loose earth produced from the executed of trenching to the satisfaction of NHAI.
- 6. If any accident occurs during the execution or completion of work by the agency, the complete responsibility lies with the head or agency.
- 7. To abide by the directions of the concerned officer of NHAI appointed in accordance with the National Highways Act 1956 and rules in force. Also, IOCL shall conform to all standard condition of NHAI's guidelines and ministry circular.
- 8. To relocate service/approach road/ utilities at their own cost notwithstanding the permission granted within such time as will be stipulated by NHAI.
- 9. Not to damage to other utility, if damages, then to pay losses either to NHAI or to the concerned utility agency.
- 10. Indemnify NHAI against all damages and claims.
- 11. If any claim is raised by the Concessionaire, then the same has to be paid by the applicant.
- 12. To bear the expenditure, if any incurred by NHAI for repairing any damage caused to the National Highway by the laying, maintenance or shifting of the underground R-LNG pipeline will be borne by the agency owning the line.

- 13. If the NHAI considers it is necessary in future to move the utility line for any work of improvement or repairs to the road, it will be carried out as desired by NHAI at the cost of the agency owning the utility line within a reasonable time (not exceeding 60 days) of the intimation given.
- 14. Laying of underground R-LNG pipeline will not have deleterious effects of any of the bridge components and roadway safety for traffic.
- 15. To relocate service/approach road/ utilities at their own cost notwithstanding the permission granted within such time as will be stipulated by NHAI for future six laning or any other development.
- 16. All the restoration work will be carried out by Indian Oil Corporation Limited, South Eastern Region Pipelines, City Gas Distribution and Guntur up to the satisfaction of NHAI.
- 17. The licensee shall make their own arrangement for crossing of cross drainage structures, rivers, etc., below the bed. In case this is not feasible, the utility services may be carried outside the railings/parapets and the bridge structure. The fixing and supporting arrangement with all the details shall be required to be approved in advance from the concerned Highway Administration. Additional cost on account for fixing and supporting arrangement as assessed by the authority shall be payable by the licensee.
- 18. To manage traffic movement during laying of Natural Gas Pipeline.
- 19. To pay necessary fees/rent including Bank Guarantee as and when required by NHAI as per their circular No. 33044/29/2015/S&R(R) dated 22.11.2016 without any delay.
- 20. To restore any damaged portion of NHAI service road as per existing crust thickness i.e., Sub Grade 500MM, GSB 150MM, WMM 250MM, DBM 50MM & BC 30MM.
- III. As per the plans submitted, the applicant has proposed to lay 4" Carbon steel pipeline and 125mm MDPE pipe along with 40mm HDPE duct for public utility along the service road from Km. 430+630 to Km.431+030 LHS and from Km.431+030 to Km. to Km.415+300 on RHS, & from Km.416+030 to Km.416+120 on LHS with crossings at Km.415+300 & Km.411+400 by Horizontal Directional Drilling method at the edge of ROW.
- IV. Applicant has submitted methodologies for laying of 4" dia Carbon steel pipe line along with 40mm HDPE Duct for OFC cable with open trenching method and HDD method along the National Highway and are found in order.
- 7. While submitting the above, IE recommended the proposal of IOCL to lay 4" dia Carbon steel pipeline and 125mm MDPE pipe along with 40mm HDPE duct along the NH-16 ROW as requested by the applicant.
- 8. The proposal has been examined in this office and PIU vide reference 5th cited communicated the following observations to M/s IOCL and requested to submit compliance:

- i. The applicant has proposed to lay 4" dia carbon steel pipeline along with 125mm MDPE pipeline and 40mm HDPE OFC duct, whereas in the submitted typical cross section for open trench method 12.75" dia steel pipe line with 100mm MDPE and 100mm HDPE OFC duct is shown and the same may be clarified.
- ii. The applicant has not submitted cross section for HDD methodology as per site condition.
- 9. The compliance submitted by M/s IOCL has been examined in this office and found to be in order.
- 10. M/s IOCL has submitted calculation for Performance Bank Guarantee for Rs. 4,70,300/- at a rate of Rs.100/- per metre and the same is in accordance with MoRTH guidelines
- 11. As per point no. III 2(b) of MOU dated 07.06.2022 NHAI shall not levy any charges from IOCL for laying of gas pipeline.
- 12. The applicant has furnished a copy of authorization letter issued by Petroleum and Natural Gas Regulatory Board for Kurnool, Guntur and Prakasam District vide letter no. PNGRB/Auth/CGD(14)/2021/11.01 dated 15.03.2022.
- 13. Further, it is to submit that the location falls under Chilakaluripet-Vijayawada section of NH-16 and the BoT(Toll) Concession period was completed on 21.07.2024. Hence, objections of the Concessionaire are not required.
- 14. The proposal of laying of steel pipeline for Public Utility "City Gas Distribution" has been examined in this office along with the comments of IE and found to be in line with guidelines issued vide MoRTH Circular dated 22.11.2016 and MOU signed between M/s IOCL and NHAI on 07.06.2022.

In light of the above, the proposal along with the copies of all the above mentioned documents are herewith submitted with a request to communicate the approval of the Competent Authority for laying of steel pipelines for Public Utility - "City Gas Distribution" along the NH-16 from Km.430+630 to Km.431+030 LHS and from Km.431+030 to Km.435+233 RHS with crossing at Km.431+030 for a total length of 4703m (4603 m along and 100m crossing) on Chilakaluripet - Vijayawada section of NH-16 in the state of Andhra Pradesh.

- The applicant has proposed to lay 4" dia carbon steel pipeline along with 125mm MDPE pipeline and 40mm HDPE OFC duct, whereas in the submitted typical cross section for open trench method 12.75" dia steel pipe line with 100mm MDPE and 100mm HDPE OFC duct is shown and the same may be clarified.
- The applicant has not submitted cross section for HDD methodology as per site condition.

It is therefore requested to submit compliance to the observations for taking further needful action in the matter.

1. - 3. To obtain prior permission in writing to the concerned officer of NHAI to undertake any work of shifting, repairs or alteration to the laid pipeline by Indian Oil Corporation Limited, Pipeline Division, City Gas Distribution, Guntur
- 4. NHAI shall not be responsible for any damage caused to the underground R-LNG pipeline or by any activity of NHAI of the permitted highway. The parties are agreed that the Indian Oil Corporation Limited, Pipelines Division, City Gas Distribution, Guntur is laying an underground LNG pipeline across the permitted highway at its own cost.
- 5. To make good excavated trench for laying underground R-LNG pipeline by proper filling and compaction, so as to restore the land in the same condition as it was before digging trench and shall clear the debris/loose earth produced from the executed of trenching to the satisfaction of NHAI.
- 6. In any accident occurs during the execution or completion of work by the agency, the complete responsibility lies with the head or agency.
- 7. To abide by the directions of the concerned officer of NHAI appointed in accordance with the National Highways Act 1956 and rules in force. Also, we shall conform to all standard condition of NHAI's guidelines and ministry circular.
- 8. To relocate service/approach road/ utilities at their own cost notwithstanding the permission granted within such time as will be stipulated by NHAI.
- 9. Not to damage to other utility, if damages, then to pay losses either to NHAI or to the concerned utility agency.
- 10. The applicant has to Indemnify NHAI against all damages and claims.
- 11. If any claim is raised by the Concessionaire, then the same has to be paid by the applicant.

Additional cost on account for fixing and supporting arrangement as assessed by the authority shall be payable by the licensee.
- 18. To manage traffic movement during laying of Natural Gas Pipeline.
- 19. To pay necessary fees/rent including Bank Guarantee as and when required by NHAI as per their circular No. 33044/29/2015/S&R(R) dated 22.11.2016 without any delay.
- 20. To restore any damaged portion of NHAI service road as per existing crust thickness i.e., Sub Grade 500MM, GSB 150MM, WMM 250MM, DBM 50MM & BC 30MM.

- .3. As per the plans submitted, the applicant has proposed to lay 4" OD Carbon steel pipeline and 125mm MDPE pipe along with 40mm HDPE duct for public utility along the service road from Km. 430+630 to Km. 430+800 on LHS & Km. 430+800 to Km. 435+233 on RHS and Km. 430+800 across the NH-16 by open trench method and Horizontal Direction Drilling (HDD) method respectively at the edge of NH-16 RoW.
- 4. Applicant has submitted methodologies for laying of 4" OD Carbon steel pipeline and 125mm MDPE pipe along with 40mm HDPE duct with open trenching method and HDD method along the National Highway.
