


INVITATION OF PUBLIC COMMENTS

Sub: 6-laning of Barwa Adda - Panagarh section of NH-2 from Km 398.240 to Km 521.120 including Panagarh Bypass in the state of Jharkhand & West Bengal under NHDP Phase-V on BOT (Toll) on DBFOT pattern - Permission for laying of water pipeline along NH-2 from Kallamore (Km 462+080) to Harishpur (Km 481+918) and 7 nos of crossing across NH-2 in the state of West Bengal under RCFA Divn-I, OPHE Dte.:- Reg.

The Project Director, PIU-Durgapur, NHAI vide letter no: 15017 / 1 / 20213 / PIU (DUP) / PHED / 462.080 to 481.918/7005 dated 09/10.04.2024 has submitted the subject mentioned proposal for granting licenses for use of National Highway land.

2. The proposal for laying of water pipeline along NH-19 (old NH-2) is under:
