Khavda-Bhuj Transmission Ltd. Bhuj in the State of Gujarat -Reg.

The Roads and Building Department, Government of Gujarat vide letter no. NHP-14-2024-423-M dated 11/06/2024 has recommended the subject cited Proposal for permission for crossing of overhead electric line of 765KV D/C Khavda (KPS2) Lakadia Transmission line between km 119/600 to km 119/700 on NH-754K under the scheme for evacuation of 4.5 GW RE injection at Khavda P.S under Phase-II of M/s. 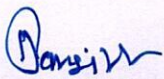
