Tamilnadu Water Supply and Drainage Board	Walajahpet Section of NH- 48 - Crossing at Km. 87+551	The top of the casing / conduit pipe containing the utility services to cross the road shall be at least 1.2m below the top of the sub-grade or the existing ground level whichever is lower subject to being at least 0.3m below the drain inverts. The crossing of the Pipeline shall be square i.e., it should be normal to the NH by Trenchless Method.

 The applicant M/s. Tamilnadu Water Supply and Drainage Board has furnished an undertaking to relocate UG Cable / Utilities at their cost notwithstanding the permission granted within such time as stipulated by NHAI for future widening or any other development.
