The license fee shall be submitted through online portal for NTRP collection i.e. through BHARATKOSH portal (<https://bharatkosh.gov.in/>) within 15 days and BG for restoration charges. The receipt of online license fee deposition should be submitted to this office with intimation to the Executive Engineer, NH-Division, Ahmedabad. The BG should be in favor of the Executive Engineer, NH- Division, Ahmedabad (as per prevailing procedure in R&B Dept.) and to be submitted to Executive Engineer, NH- Division, Ahmedabad custodian of BG/s.
