Subject- Proposal of permission for laying 125 mm PE gas pipeline along Amreli bypass road from km. 83/210 to km 83/920, km 78/975 to km 79/085 and crossing Amreli-Bagasara road at km 84/650 on NH-351G in the State of Gujarat.

The Roads and Building Department, Government of Gujarat vide letter no. NHP-13-2025-6-M dated 18.01.2025 has recommended the subject cited proposal for permission for laying 125 mm PE gas pipeline along Amreli bypass road from km. 83/210 to km 83/920, km 78/975 to km 79/085 and crossing Amreli-Bagasara road at km 84/650 on NH-351G in the State of Gujarat for approval of Highway Administration cum RO, Gandhinagar.

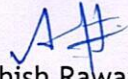
