Proposal seeking permission for Crossing & Parallel 1100mm Dia MS Carrier Pipe with 1600mm Dia MS Casing Pipe (across proposed at Km 21+770 and along from Km 21+770 to Km 21+985 on LHS and from Km 21+770 to Km 22+027 on RHS) by Pushing Open Excavation Method on Hazira-Dhulia NH-53-Surat in the state of Gujarat.


