
3. As per guideline issued by Ministry vide letter no. RW/NH-33023/19/99-DO-III ,dated 16.03.2016 according to which for relaxation cases the ,Highway Administrator will make available in Ministry website the complete application for public comments and comments will be invited within 60 days from the day of uploading as per the format enclosed as Form-A. As per proposal due to following the relaxation is sought by applicant.

i)	Non Fulfillment of Criteria of construction within in a year of issuing of NOC.	i) The IOCL also submitted that, the remaining work could not be completed because of the ongoing road widening work at Kalyan-Nirmal road (Old 222) NH-61. The work of widening of the road (NH-222) is in progress. The levels of existing road are likely to be realigned and will be lowered by at least 205m.
