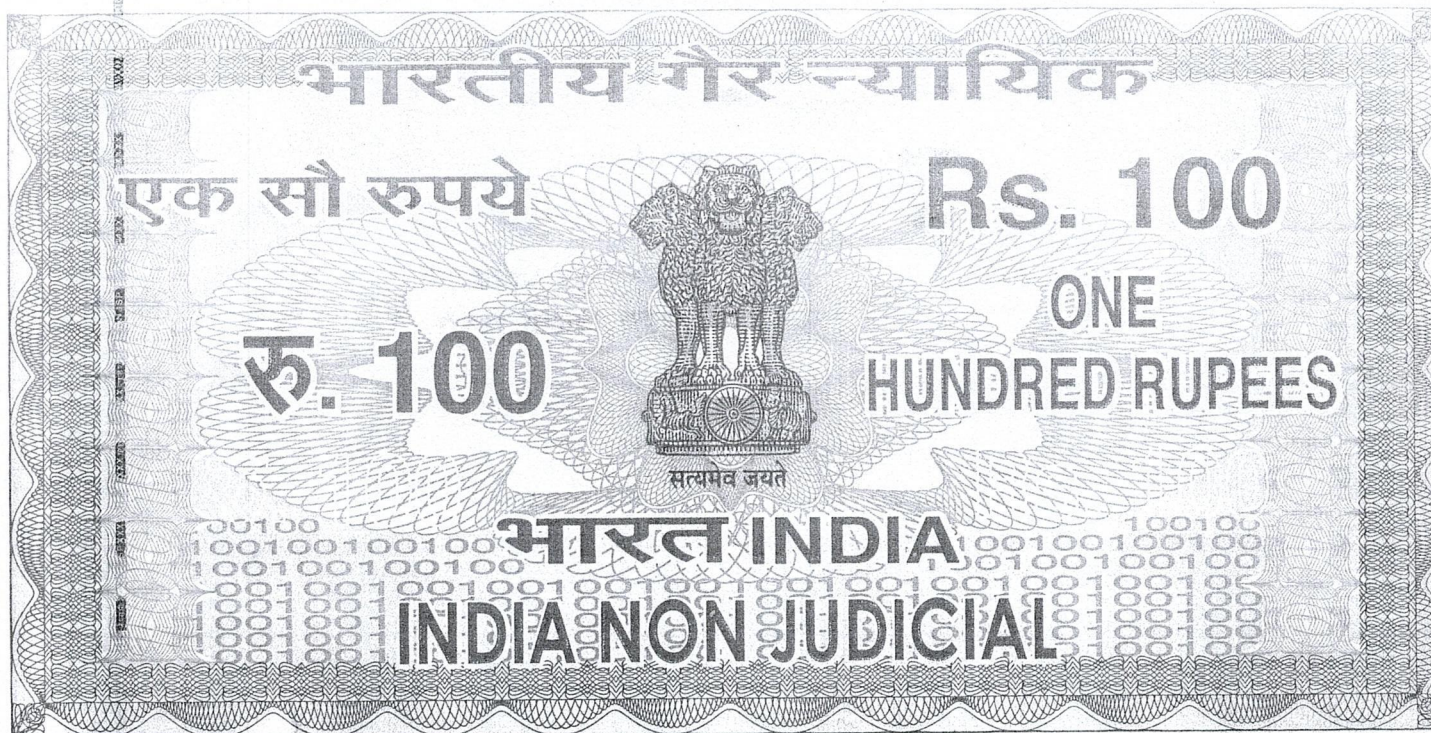

Please refer your letter no. 604.5957 dated 04.02.2020 vide which above certain observations were raised on the above said proposal.

2. In this regard, BPCL was requested to submit the compliance of the observations raised by RO Chandigarh for further processing the case. BPCL vide letter dated 14.02.2020 has submitted the compliance of observations which are as under:

- The necessary checklist is attached in which they have shown the corrected distances as measured from the tangent point of the A/L lane.
- There is no chance to damage the Highway and no any adverse effect on safety and continuity of the traffic on the Highway and also there is no any adverse effect on hygiene and pollution on the Highway for creating access on Highway for their fuel station.
- The justification of relaxation is now attached as per Annexure- I
- The processing fee has already been submitted by them and already deposited in the Central Govt account of MoRT&H, Chandigarh.

3. Further, BPCL has again requested for necessary approval with relaxation as already briefed by them in Annexure-I for above said retail outlet as per MoRT&H circular dated 16.03.2016.

4. In view of above, the proposal is hereby recommended for approval with relaxation of above said retail outlet.
