It is to inform all concern that M/s Maharashtra Information Technology Corporation Ltd. vide letter under reference (ii) has submitted a proposal for the subjected work and PD, has recommended the above proposal vide letter under reference (i) for approval of the Competent Authority / Highway Administrator.

2. The alignment proposed by M/s Maharashtra Information Technology Corporation Ltd. for permission for laying & crossing telecom cables / OFC/ ducts in stretches of Aurangabad & Paithan blocks of Aurangabad district along Solapur - Dhule road section of NH-52 (old NH-2311) from km 247.050 to km 286.900 & 8 numbers of crossing having total length 20.15 km in the State of Maharashtra. The following work is included:

- Laying & crossing telecom cables / OFC/ ducts from 247.400 to 284.235 on both side.
- Crossing at Ch. 247.400, Ch. 264.520, Ch 267.390, Ch 268.000, Ch 268.200, Ch 276.150, Ch 279.080 & Ch 281.940 through HDD method.

3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
