Invitation of Public Comments

Notice Inviting Public Comments on Permission for laying of water supply line from Km 649.500 to 663.808 and from Km 664.225 to 675.00 (RHS) of NH 150A Jewargi - Chamarajanagara section for a total length of 25.083 km excluding Dodda Kavalande village portion by KIADB - Reg.

The proposal seeking permission for laying of water supply line from Km 649.500 to 675.00 (RHS) of NH 150A Jewargi - Chamarajanagara section for a total length of 25.500 km by KIADB, is forwarded by the Executive Engineer, NH Division, Bengaluru vide letter No. EE/NHDB/AE-2/KIADB-Compliance/2018-19 dated 25.07.2018 (Annexure - I). Further, since the stretch from Km 663.808 to 664.225 is in Dodda Kavalande village limits and there is no any space for laying of pipelines, the Executive Engineer, NH Division, Bengaluru vide letter dated 18.12.2019, has forwarded the consent of the KIADB for providing encasement pipe in the village limits. Since laying of encased water supply pipeline are not permitted below the main carriageway, as it may lead to leakage of water and subsequent damage of carriageway due to heavy loads, the proposal is considered for laying of water supply line from Km 649.500 to 663.808 and from Km 664.225 to 675.00 (RHS) of NH 150A Jewargi - Chamarajanagara section for a total length of 25.083 km excluding Dodda Kavalande village portion, with the suggestion for alternative route from Km 663.808 to 664.225. The proposal is verified/certified by the Executive Engineer, NH Division, Bengaluru.

- 2. The proposal of KIADB from Km 649.500 to 663.808 and from Km 664.225 to 675.00 (RHS) of NH 150A Jewargi Chamarajanagara section for a total length of 25.083 km excluding Dodda Kavalande village portion, has been examined as per Ministry's Guidelines vide letter no.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016 and is generally found in order.
- 3. In view of above, as per Ministry's said guidelines Para 4, public comments are invited on the above proposal making claims and raising objections (on grounds of public inconvenience, safety and general public interest) if any within 30 days on public portal i.e., website of Ministry of Road Transport and Highways (morth.nic.in) in Form-A (copy enclosed) for "Accommodation of Public and Industrial Utility Services along and across National Highways".
